Francis Burch made a motion to accept the Claims in the amount of \$12,442.98. Albert Teubert 2<sup>nd</sup> the motion. Motion carried.

## Treasurer's Report:

Albert Teubert made a motion to accept the treasurer's report. Francis Burch 2<sup>nd</sup> the motion. Motion carried.

#### Road Report:

Francis Burch suggests to add 10 yards of rock as a base at end of 150<sup>th</sup> Street and continue on gravel on cartway. Ryan Ide made a motion to hire Klehr to take care of project. Albert Teubert 2<sup>nd</sup> motion. Motion carried.

Ryan Ide made a motion to hire Klehr to add 8" of PVC in road on 160<sup>th</sup> inbetween Eagle Ave and CR15 in ROW for 30 feet to help with water flow. Klehr to bring gravel. Francis Burch 2<sup>nd</sup> motion. Motion carried.

Two estimates were recived from Rickert Excavating to raise Sheldon Ehrke's cartway (\$2,720.00) and to replace shallow culvert (\$1,475.00). Albert Teubert made a motion to accept both estimates. Ryan Ide 2<sup>nd</sup> the motion. Motion carried.

On Eagle Ave, needs a 3 to 1 slope on hill across from house. Rickert suggested bringing excavator to dig down and make a 3 to 1 all along the road. Francis Burch made a motion to have Rickert make road ditch 3 to 1 with a cap spend of \$5000. Ryan Ide 2<sup>nd</sup> the motion. Motion carried. This payment is subject to Rickert viewing without grass seeding. Will attend the monthy meeting in June if can't do the work for under \$5000.

Eagle Ave grass seed needs to be redone. Alberte Teubert made a motion to get ROW reseeded when RIckert is completed with work. Ryan Ide 2<sup>nd</sup> the motion. Motion carried.

#### Old CR 84 Discussion:

- Ron Shimanski was present. Road getting rough and citizens on road are complaining.
- John Brunkorst and Elvis Voigt going to look at road and put it on list for sealcoating in 2019
- Shimanski knows it needs repair. They are looking for a civil engineer.
- Ryan Ide asked that when there are updates that Bergen Township be notified of what is going on.
- Bergen Township will be notifiying them that we as a township do not want back CR84 when our contract ends.
