

June 13th, 2018 Regular Meeting Minutes

Road + Bridge Fund: Beginning Balance: \$165,305.43 receipts \$0, disbursements \$9,142.00 a balance of: \$156,163.43

Fire Fund: Beginning Balance: \$5,603.97 Receipts \$0, disbursements \$3,133.44, for a balance of: \$2,470.53

Francis Burch made a motion to accept the treasurer's report. Ryan Ide 2nd the motion. Motion carried.

Road Report:

Sherrif Rossow said there is nothing new to report in Bergen Twp.

Board requested clerk to send land owner on corner of 167th and Eagle ave to request not to put field rock in ROW.

Jeff Kler stated we need more gravel in certain areas:

- Eagle Ave. and 130th – needs more gravel due to frost boil - 2 loads
- Eagle Ave and CR 74, intersection south – 1 load
- Cartway on 150th turnaround needs- 2 loads

Discussion took place regarding 175th between Babcock and CR9, on the East side. Needs tile line put in and more gravel added. Ryan Ide to obtain a quote on tiling.

Discussion took place regarding 150th street and the edges of road are creeping inward (grass). Kler advised the board to spray the grass so he can grade correctly.
