# December 7th, 2016 Meeting Minutes

General Fund: Beginning Balance: (\$5,793.96), receipts \$339.26, disbursements \$1,653.00 for a balance of: (\$7,107.70)

Road + Bridge Fund: Beginning Balance: \$208,137.37, receipts \$3,264.16, disbursements \$6,447.74 for a balance of: \$204,953.79

Fire Fund: Beginning Balance: \$28,945.52, receipts \$0.00, disbursements \$4,184.28 for a balance of: \$24,761.24.

Angela said 2<sup>nd</sup> quarter property taxes came back so the General Fund will be back in the black in December.

Angela said Cindy Schultz from McLeod County reported that Bergen Twp paid the 2016 assessment fee twice. It was mentioned by the Clerk they sent us duplicate invoices. McLeod County will void the November check #4717 in the amount of \$7,171.50.

CD Renewal – coming up for renewal in December 2016. Treasurer got quotes from 3 different banks. Ryan Ide made a motion to accept the renewal at 15 months at 1.05% APR with Security Bank and Trust in Glencoe. Albert Tuebert 2<sup>nd</sup> the motion. Motion carried.

# Road Report:

Mr. Klehr reported they graded before the freeze but it was a very wet season and they tried their best to complete it to standards. He thinks the roads are mostly in nice condition.

# Public Agenda Request & Walk in items:

Andrew Jackson came back to update the board on the refurbishing project he'd like to do for his boy scout project at Packer Cemetery. He will gather more information to present at our 2017 March Annual Meeting. Currently he figured the following costs to repair some of the damage that has occurred over the years:
